### **CYA On Water Regatta Liability**

As your club or Association is a current member of the Canadian Yachting Association, it has access to the CYA Regatta Liability Insurance Policy. The Regatta Liability Policy was designed specially for CYA members who were having trouble obtaining "third party bodily injury" coverage for the on-water part of their general insurance program.

The policy is written through Lloyd's of London on a Comprehensive General Liability Policy covering bodily injury (i.e. not property damage). The policy covers your organization and it's officers, directors, judges, sponsors, volunteers, employees and the full race management team in the course of their duties on the water for any legal liability to third parties.

This policy also pays for legal expenses to defend any lawsuits. The coverage begins when the boats leave their mooring or anchorage and continues throughout the race until they return to their mooring or anchorage immediately following either their completion of the race or their retirement from the race. The territory covered is Canada and the United States of America.

The coverage has a limit of \$5,000,000 and any members who wish to be added to the policy will become an "Additional Named Insured" under the master policy issued to the Canadian Yachting Association. Please note that the term for the master policy runs from March 1<sup>st</sup> to March 1<sup>st</sup> each year.

Coverage begins upon:

- Receipt of a completed additional named insured request form and premium cheque
- Verification of current membership with the CYA

Please complete the additional named insured request form and send it and the premium cheque to Thomson Jemmett Vogelzang.

The sooner your completed form is received, the sooner the coverage begins.
